

# **USA Game Lover's Giveaway**

### Official Rules

Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. The USA Game Lover's Giveaway ("Sweepstakes") will begin at 12:00 AM Eastern Daylight Time (EDT) on September 17, 2024, and end at 11:59 PM EDT on October 22, 2024. Sweepstakes is managed by the Union Sportsmen's Alliance ("USA") a Tennessee non-profit corporation located at 4800 Northfield Lane, Spring Hill, TN 37174. Prizing is supplied by the USA.

**Eligibility:** Sweepstakes entry is open to all USA members. All entrants must be 18 years of age or older as of September 17, 2024, and legal residents of the 50 United States, Washington, D.C., or Canada. Contest is open to all legal residents of the residents of the 50 United States, Washington, D.C., or Canada.
